RESOLUTION 01-2011

A RESOLUTION DECLARING THE NECESSITY OF LEVYING AN INCREASE IN YEARLY F.O.P. DUES TO COVER AN INCREASE IN THE STATE AND GRAND LODGE PER CAPITA MEMBERSHIP TAXES, ASSESSMENTS, FEES AND ADMINISTRATIVE COSTS

WHEREAS, the Executive Board of the Ohio Valley F.O.P. Lodge 112 has been advised of an increase in membership Per Capita Taxes, assessments of certain fees and administrative costs by the Ohio State Lodge and the Grand Lodge of the Fraternal Order of Police, and

WHEREAS, pursuant to Article VI, Section 1 of the Constitution and By-Laws of the Ohio Valley Lodge #112 of the Fraternal Order of Police, two-thirds (2/3) of the members present at a regular meeting of the Lodge desire the assessment to be levied upon its members, and

WHEREAS, the same shall be ordered by the President, and notice thereof, either in writing or electronic form, shall be sent to every member of the Lodge, and

WHEREAS, the Executive Board of Ohio Valley Lodge #112 of the Fraternal Order of Police, by a majority vote, is in agreement with the increase in membership dues, certain assessments and fees,

NOW THEREFORE, be it resolved by a vote of two-thirds (2/3) of the members present at a regular meeting of the Ohio Valley F.O.P. Lodge #112 that:

SECTION 1. Pursuant to provisions of Article VI, Section 1, of the Ohio Valley F.O.P. Lodge #112, it is necessary that an increase in annual dues be levied.

SECTION 2. Upon passage, the annual membership dues shall be as follows:

NEW MEMBER APPLICANT: \$64.00 plus a \$6.00 one time Administrative fee

ACTIVE MEMBER: \$64.00 annually

RETIRED MEMBER (AFTER YEAR 2000): \$30.00 annually

RETIRED MEMBER (BEFORE YEAR 2000): \$10.00 annually

REINSTATEMENT AFTER SUSPENSION FOR NON-PAYMENT OF DUES: \$64.00 plus a \$10 Late Fee

SECTION 3.

To become effective, this Resolution must be read to the General Membership present, on three consecutive regular meeting dates, and passed by a vote of two-thirds (2/3) of the members present, upon the third reading.

SECTION 4.

Upon passage by a vote of two-thirds (2/3) of the General Membership present, this Resolution shall take effect on April 1, 2011.
